Membership Category

All memberships require a one-year commitment. A one-time \$600 initiation fee applies to all categories (except Charter, Isthmus and Young Professionals membership). All members are assessed a capital fund fee each July. Please select your desired membership:

Standard Membership

Age 40+ years (\$208 per month)

Standard Non-Resident Membership (\$160 per month)

New members who neither live nor work in Dane County.

Affinity Plan Membership

Businesses with 2 - 5 members (\$180 per month/member)

Businesses with 6+ members (\$170 per month/member)

Social Membership (\$2440 annually; \$1440 for dues and \$1000 in pre-paid dining credits)

A Madison Club-centric membership for those not desiring reciprocity. All credits must be used within one calendar year; carryover is not permitted.

Executive Membership (\$148 per month, plus a \$300 spending minimum per quarter)

An economical program for frequent users. All credits must be used within each quarter; carryover is not permitted.

Charter Membership (\$1,320 one-time fee for the year)

The wedding membership, intended for couples that book their wedding at the Club. Charter members are excluded from initiation or Capital Fund fees.

Young Professionals Membership (\$60 per month)

Valid for one year for any new member under the age of 40. \$100 initiation fee, 50% off capital fund fee assessed each July.

Non-Profit Membership (\$160 per month)

New members who currently work for a non-profit organization.

Isthmus Membership (\$50 dues + \$50 spending minimum per month for first year; \$75 dues/\$75 spending minimum second year)

New members only. 2-year membership commitment. \$100 off initiation fee and no capital assessment charged your first year.

All members are assessed a capital fund fee each July. This fee assists with capital improvement projects and changes annually.

The 2020 assessment fee is expected to be \$500.

Parking

There are forty "Madison Club Members Only" parking spots reserved in the Hilton parking ramp. A deposit of \$25 plus a monthly fee of \$42 is required for parking privileges for one permit; a deposit of \$35 plus a monthly fee of \$52 for two permits. If you do not wish to purchase a parking permit, please park in an unmarked spot as the Madison Club spots are reserved for permit holders.
